COLLECTIVELY, CCS HAVE MORE THAN 600,000 MEMBERS AND TOUCH THE LIVES OF 2.6 MILLION PEOPLE AROUND THE WORLD. URI'S UNIQUE GLOBAL NETWORK OF GRASSROOTS CCS CALLS FORTH LOCALLY INITIATED ACTIONS BY SELF-SUPPORTING GROUPS AND ORGANIZATIONS. CCS CAN BE SMALL GROUPS ORGANIZING FOR THE FIRST TIME OR WELL-ESTABLISHED ORGANIZATIONS. 


